Call for “MUSICAL EXCHANGE – RUMORE BIANCO”

CALL FOR THE SELECTION OF A CHAMBER MUSIC GROUP TO BE HOSTED AT THE THIRD EDITION OF THE “ RUMORE BIANCO”

The Furano Saxophone Quartet, in collaboration with the cultural organization “ Note a Sud”, with the aim of spreading the interest in contemporary music within the city of Foggia (Italy) announce a Call for the selection of a Chamber Music group to be hosted at the third edition of the “ RUMORE BIANCO” Contemporary Music Festival scheduled for the months of April /May 2020 in Foggia (Italy). The purpose of the Call is to establish a cultural exchange between Italian and European musical realities active in Contemporary Music.

Art. 1 - Economic conditions

The winning group will be hosted within the third contemporary music festival to be held in Foggia in May 2020. The date will be communicated within ten days of the announcement of the winning group. The winner will receive a reimbursement of expenses amounting to 1,200 euros which will be paid at the end of the Festival. The organization of the trip, board, lodging, and any other specific requirement, remains the responsibility of the winning group. Art. 2 Conditions of participation

Musical groups are admitted from the duo to the octet (organic free, also with piano), Italian and/or European, without age limits, owners of VAT number in individual form or set up in association, and whose purpose is the dissemination of music contemporary and new expressions of art.

The use of electronics is not allowed.

The winning group, in order to exchanging and disseminating new contemporary musical realities, is committed to hosting the Furano saxophone quartet in a concert organized by him.

The concert must be organized between September 2020 and April 2021 under the same conditions as the Furano Saxophone Quartet will host the winner of the call (reimbursement of expenses equal to 1,200 Euros). A contract will therefore be stipulated in which the parties undertake to respect the agreements.

The participation to the competition is FREE

03 April 2020 publication of the result of the Announcement.

Art.4-Jury

The Jury is composed by the members of the Furano Saxophone Quartet:

The judgment of the jury is final, furthermore it reserves the right not to award the prize.

Art. 5 - Sending proposals

The PDF proposals must be sent by **March 31, 2020** to the email address: **noteasud@gmail.com**, indicating in the subject "Musical Exchange - Rumore Bianco 2020"

In the participation form, each participating group must indicate its concert proposal and explain the aesthetic purposes of this choice. He will also have to describe the place and reality in which he intends to host the Furano Saxophone Quartet in case of victory. Each group may submit more than one proposal. Each participant must attach.

- 1) the registration form, downloadable from the website **www.furanosaxquartet.com**;
- 2) a detailed curriculum of the group and of the association;
- 3) the declaration of full and unconditional acceptance of all the conditions of the announcement;
- 4) copy of a valid identity document of a legal representative of the association;
- 5) Vat number

Art. 6 – Benchmarks

A table with 4 parameters will be formulated and a score will be assigned to each of them from 1 to 5. The group that obtains the highest score will be named the winner of the competition.

The parameters in question will be:

- CURRICULUM OF THE MUSIC GROUP AND OF THE ASSOCIATION
- ACTIVITIES ON THE NATIONAL AND INTERNATIONAL TERRITORY FOR THE DISCLOSURE OF CONTEMPORARY MUSIC
- PROPOSED CONCERT PROGRAM
- PRESENCE OF ABSOLUTE FIRST EXECUTIONS
